9		for membership by Resolution 03-301; and
10	WHEREAS,	the Enrollment Program discovered that this same member was mistakenly
11		approved a second time for membership by Resolution No. 07-075; and
12	WHEREAS,	the Enrollment Program therefore recommends that Resolution No. 07-075 be
13		amended to delete the member identified in the attached Amending Enrollment
14		Resolution List for May 2024; and
15	WHEREAS,	the member that was originally approved in Resolution No. 03-301 will retain the
16		roll number and approval date identified in that resolution.
