17	WHEREAS,	by Chukut Kuk District Council Resolution No. 2024-14, the Chukut Kuk District
18		has authorized and submitted for review and approval its FY 2024 Chukut Kuk
19		District Mining Royalties Budget Amendment No. 3, which is incorporated by this
20		reference and which will adjust operational and/or personnel line items; and
21	WHEREAS,	the FY 2024 Chukut Kuk District Mining Royalties Budget Amendment No. 3 will
22		increase the FY 2024 Chukut Kuk District Mining Royalties Rudget by \$26,928.74
23		from \$231,765.42 to \$258,694.16; and
24	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District
