14		amount of \$9,382.00; and
15	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
16		reviewed the FY 2025 Department of Health and Human Services Division of
17		Senior Services Title VI Part A Budget, Title VI Part C Budget, and Title VI Nutrition
18		Services Incentive Program Budget and recommend their approval.

31		provided that any amendments or modifications shall be submitted for prior
32		approval by the Tohono O'odham Legislative Council.
