5		authorized by resolution or ordinance (Constitution of the Tohono O'odham
6		Nation, Article VI, Section 1(d) (2)); and
7	WHEREAS,	the FY 2024 Department of Health and Human Services, Division of Senior
8		Services Elders Day Budget in the amount of \$113,550.00 was approved by
9		Resolution No. 23-182; and
10	WHEREAS,	the Department of Health and Human Services, Division of Senior Services
11		prepared and submitted for review and approval its FY 2024 Elders Day Budget
12		Amendment No. 1, which is incorporated by this reference, and which will adjust
13		operational line items to increase the hudget by \$50,000.00 from \$113,550.00 to
14		\$163,550.00, of which \$3,000.00 shall be funded from program revenues and
15		\$160,550.00 from Nation's General Fund surplus; and
16	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
17		reviewed the FY 2024 Department of Health and Human Services, Division of
18	:	Senior Services Elders Day Budget Amendment No. 1 and recommend its
19		approval.
20	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		FY 2024 Department of Health and Human Services, Division of Senior Services
22		Elders Day Budget Amendment No. 1, effective October 1, 2023, which will
23		increase the budget by \$50,000.00 from \$113,550.00 to \$163,550.00, of which
24		\$3,000.00 shall be funded from program revenues and \$160,550.00 shall be
25		funded by the Nation's General Fund surplus.
26	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
27		Nation chairperson or any designated official is authorized to administer and
28		expend the FY 2024 Department of Health and Human Services, Division of Senior
29		Services Elders Day Budget as amended, provided that any amendments or
30		modifications shall be submitted for prior approval by the Tohono O'odham
31		Legislative Council.
