11		\$38,444.50 which remain unobligated, further, an unexpended balance of
12		\$8,195.54 remains from the FY 2023 budget for a total amount of \$ 46,639.84
13		available to be budgeted; and
14	WHEREAS,	Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
15		Hewel Ni'ok Dedicated Revenue Budget, which is incorporated by this reference,
16		in the amount of \$46,639.84 to be funded from the Dedicated Revenue Account;

18	WHEREAS,	the Cultural Preservation and the Budget and Finance Committees have reviewed
19		the FY 2024 Hewel Ni'ok Dedicated Revenue Budget and recommend its approval.
20	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		FY 2024 Hewel Ni'ok Dedicated Revenue Budget effective October 1, 2023, in the
22		amount of \$46,639.84 which shall be funded from the Dedicated Revenue Account
23		of Hewel Ni'ok.
