9		Resolution No. 23-164 and subsequently amended by Resolution 24-066; and
10	WHEREAS,	the Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
11		Budget Amendment No. 2 which is incorporated by this reference, and which will
12		create and fund account 6530-Transportation, adjust personnel line items and
13		the indirect cost estimates; and
14	WHEREAS,	the FY 2024 Hewel Ni'ok Corporation for Public Broadcasting Community Service
15		Grant Unrestricted Budget Amendment No. 2 will increase the FY 2024 Hewel
16		Ni'ok Corporation for Public Broadcasting Community Service Grant
17		Unrestricted Budget by \$34,937.09, from \$227,087.96 to \$262,025.05; and
18	WHEREAS,	the Cultural Preservation and Budget and Finance Committees have reviewed the
19		FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
20		Service Grant Unrestricted Budget Amendment No. 2 and recommend its
