

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting July-December 2024 General Session Locations)**

**LEGISLATIVE ORDER NO. 24-160**

1 **WHEREAS,** the Legislative Council is vested with the power to “establish rules and  
2 procedures to regulate all meetings of the Tohono O’odham Council, standing  
3 committees, boards and special committees.” (Constitution of the Tohono  
4 O’odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Council, by Legislative Order No. 24-110, adopted its official  
6 calendar setting dates for monthly general sessions from June 2024-June 2025  
7 (Legislative Rules of the Tohono O’odham Legislative Council, Article I, Section  
8 1(A)(1)); and

9 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O’odham Legislative  
10 Council provides that “All Legislative Council sessions shall be held at the Tohono  
11 O’odham Legislative Council chambers located in Sells, Tohono O’odham Nation,  
12 with the following exceptions . . . [a] majority of all the legislative representatives  
13 may vote to hold a session in some location other than the chambers located at  
14 Sells.”; and

15 **WHEREAS,** the Legislative Branch is in the process of replacing the current Council meeting  
16 rooms and chambers in Sells, and it is in the best interest of the O’odham to  
17 conduct Council sessions in other communities on the Nation; and

18 **WHEREAS,** the Rules Committee has reviewed the July-December 2024 Legislative Council  
19 general session meeting locations and recommends approval.

20 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O’odham Legislative Council that it sets the  
21 following locations for the July-December 2024 Legislative Council general  
22 sessions:




