| 2 | WHEREAS, | Fitzpatrick J. Ignacio, Sr. ("Mr. Ignacio") is the sole owner and proprietor of |
| 3 | | Tobacco Barn, which has been an active tobacco retail business within the Nation |

| 5 | WHEREAS, | Tobacco Rarn owes the Nation unpaid tax obligations, including interest and |
| 6 | | penalties, accrued between 2011 and 2021 ("Total Obligation"); and |
| 7 | WHEREAS, | since Tobacco Barn has accrued tax debts, it cannot obtain a five-year |
| 8 | | Transaction Privilege Tax ("TPT)" Tobacco License or Retail License to conduct |
| 9 | | business on the Nation and instead conducts husiness under a renewable 90-day |
| 20 | | temporary license; and |
| 21 | WHEREAS, | the Nation has negotiated a confidential Taxation Settlement with Tobacco Barn |
| 22 | | ("Exhibit A"), incorporated by this reference, to reduce Tobacco Barn's unpaid |
| 23 | | Total Ohligation and issue Tobacco Barn a five-year TPT License for tohacco sales |
| 24 | | and retail as separate or combined licenses, so long as Tobacco Barn complies |
| 25 | | with all terms and conditions of the Taxation Settlement; and |
| 26 | WHEREAS, | the Office of the Treasurer may not issue a five-year TPT Tobacco License or Retail |
| 27 | | License until the Taxation Settlement is fully executed; and |

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the Taxation Settlement Agreement between the Tohono O'odham Nation and Mr. Fitzpatrick J. Ignacio, Sr., D/B/A Tobacco Barn, and authorizes the Tohono O'odham Office of the Treasurer to issue a new five-year TPT License for tobacco sales and retail as separate or combined licenses to Mr. Fitzpatrick I. Ignacio, Sr., D/B/A Tobacco Barn, a TPT-Tobacco Tax License and renewals, upon execution of the Taxation Settlement Agreement, subject to revocation if Mr. Fitzpatrick J. Ignacio, Sr., D/B/A Tobacco Barn, fails to comply with the Taxation Settlement Agreement.

BE IT FURTHER RESOLVED that the Taxation Settlement Agreement (Exhibit A) is confidential and can only be disclosed at the written request of the Office of Attorney General or the Nation's Office of the Treasurer.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham

Nation chairperson or any designated official shall sign and authorize the

Taxation Settlement substantially in the form attached, provided that any
substantive amendments or modifications shall be submitted for prior approval
by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH day of JUNE 2024 at a meeting at which a quorum was present with a vote of 3,134.5 FOR; 128.8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(4),(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
