15		will not change the original budget of \$3,679,910.12; and
16	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
17		reviewed the FY 2024 Department of Education Recreation Division Budget
18		Amendment No. 1 and recommend its approval.
