6		Tohono O'odham Council" (Constitution of the Tohono O'odham Nation Article
7		VI, Section 1(f)); and
8	WHEREAS,	in 2021, the Tohono O'odham Nation Legislative Council passed Resolution No.
9		21-343, which approved an Intergovernmental Agreement ("IGA") (ADES Contract
10		Number DI21-002302) with the Arizona Department of Economic Security for
11		Workforce Innovation and Opportunity Act ("WIOA") Title 1B; and
12	WHEREAS,	in 2022, the Tohono O'odham Nation Legislative Counsel passed Resolution No.
13		22-396, which approved Amendment No. 1 to the IGA; and
14	WHEREAS,	in 2023, the Tohono O'odham Nation Legislative Counsel passed Resolution No.
15		23-300, which approved Amendment No. 2 to the IGA; and
16	WHEREAS,	the Department of Education has submitted for review and approval the Arizona
17		Department of Economic Security WIOA Title 1B IGA Amendment No. 3,
18		incorporated by this reference, which will increase the contract reimbursement
19		ceiling by \$659,790.00, from \$2,137,156.00 to \$2,796,946.00, for the period of April
20		01, 2023 through June 30, 2025; and
21	WHEREAS,	the Human Resources Development Committee has reviewed the Arizona
22		Department of Economic Security WIOA Title 1B IGA Amendment No. 3 and
23		recommends its approval.
24	NOW, THERE	EFORE, BE IT RESOLVED that the Tobono O'odham Legislative Conneil approves and
25		accepts the Arizona Department of Economic Security for Workforce Innovation
26		and Opportunity Act Title 1B Intergovernmental Agreement Amendment No. 3.
