8		\$911,345.00 was approved by Resolution No. 23-192; and
9	WHEREAS,	the Office of the Chairman and Vice Chairwoman has prepared and submitted for
10		review and approval the FY 2024 Tohono O'odham Admin Provisions Lobby
11		Budget Amendment No. 1, which is incorporated by this reference, and which will
12		adjust operational line items; and
13	WHEREAS,	the FY 2024 Tohono O'odham Admin Provisions Lobby Budget Amendment No. 1
14		will increase the FY 2024 Tohono O'odham Admin Provisions Lobby Budget by
15		\$54,000.00 from \$911,345.00 to \$965,345; and
16	WHEREAS,	the Appropriations and Budget and Finance Committees have reviewed the FX
17		2024 Tohono O'odham Admin Provisions Lobby Budget Amendment No. 1 and
18		recommend its approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		FY 2024 Tohono O'odham Admin Provisions Lobby Budget Amendment No. 1,
21		which includes a \$54,000.00 increase from \$911,345.00 to \$965,345.00 that shall
22		be funded by the Nation's general fund surplus.
