The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. the FY 2024 Schuk Toak District Budget in the amount of \$3,757,274.26 was 13 authorized by Schuk Toak District Council on Resolution No. ST-08-29-23-089 and 14 approved by Legislative Council Resolution No. 23-366; and 15 WHEREAS, by the Schuk Toak District Council Resolution No. ST-05-25-24-050, the Schuk 16 Toak District has authorized and submitted for review and approval its FY 2024 17 Schuk Toak District Administration Budget Amendment No. 1, which is 18 incorporated by this reference and which will adjust operational and/or 19 personnel line items; and 20 WHEREAS. the FY 2024 Schuk Toak District Administration Budget Amendment No. 1 will not 21 change the FY 2024 Schuk Toak District Administration Budget amount of 22 \$3,757,274.26; and 23 WHEREAS, by the Schuk Toak District Council Resolution No. ST-05-25-24-051, the Schuk 24 Toak District has authorized and submitted for review and approval its FY 2024 25 Schuk Toak District Comobabi Community Budget Amendment No. 1, which is 26 incorporated by this reference and which will adjust operational and/or 27 personnel line items; and 28 WHEREAS, the FY 2024 Schuk Toak District Comobabi Community Budget Amendment No. 1 29 will not change the FY 2024 Schuk Toak District Comobabi Community Budget 30 amount of \$97,000.00; and 31

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves: the FY 2024 Schuk Toak District Administration Budget Amendment No. 1, 1. effective October 1, 2023, which will not change the FY 2024 Schuk Toak District Administration Budget amount of \$3,757,274.26; and the FY 2024 Schuk Toak District Comobabi Community Budget 2. Amendment No. 1, effective October 1, 2023, which will not change the FY 2024 Schuk Toak District Comobabi Community Budget of \$97,000.00 or the FY 2024 Schuk Toak District Budget amount of \$3,757,274.26. BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 Schuk Toak District Budget as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> day of IULY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR: -0-AGAINST; \_0\_ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
