15		adoption, or for other reasons; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 03-90, 01-449, 17-
17		122, 19-128 and 23-408 be amended to reflect the legal name changes of members
18		identified in the July 2024 Amended Enrollment Resolution Summary, which is
19		incorporated by this reference.
