

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Education Special Services IDEA Parts B and  
C American Rescue Plan Act Budget)**

**RESOLUTION NO. ~~24-214~~**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**  
8 **approval its FY 2024 Special Services IDEA Parts B and C American Rescue Plan**  
9 **Act ("ARPA") Budget, which is incorporated by this reference, in the base**  
10 **allocation amount of \$16,270.00 and indirect cost of \$1,352.09 for total of**  
11 **\$17,622.09 to be funded from the Nation's general fund pending reimbursement**  
12 **from the grantor; and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
14 **reviewed the FY 2024 Department of Education Special Services IDEA Parts B and**  
15 **C ARPA Budget and recommend its approval; and**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2024 Department of Education Special Services IDEA Parts B and C American**  
18 **Rescue Plan Act Budget, in the base allocation amount of \$16,270.00 and indirect**  
19 **cost of \$1,352.09 for total of \$17,622.09 to be funded from the Nation's general**  
20 **fund pending reimbursement from the grantor.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2024 Department of Education Special Services IDEA Parts B and C**  
24 **ARPA Budget, provided that any amendments or modifications shall be**  
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
27 **day of JULY 2024 at a meeting at which a quorum was present with a vote of ~~3,263.3~~ FOR; ~~-0-~~**  
28 **AGAINST; ~~-0-~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
