

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif Oidak District FY 1991 Budget)

1 WHEREAS, the Sif Oidak District Council has reviewed and considers
2 its proposed activities for FY 1990/1991 and have
3 prepared a budget according to its proposed expenditures;
4 and

5 WHEREAS, the Sif Oidak District Council is proposing an amount of
6 \$162,094.55 to cover the FY 1991 budget which will
7 commence on August 01, 1990 through July 31, 1991; and

8 WHEREAS, the Sif Oidak District has sufficient funds to cover the
9 proposed budget; and

10 WHEREAS, by Resolution No. 09-90 the Sif Oidak District Council did
11 approve and adopt the FY 1991 Budget.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it does hereby approve and adopt the Sif
14 Oidak District FY 1991 budget in the amount of \$162,094.55

15 The foregoing Resolution was passed by the Tohono O'odham Council
16 on the 12th day of July, 1990 at a meeting at which a quorum was
17 present with a vote of 1,724.0 for; -0- against; -0- not voting;
18 03 absent, pursuant to the powers vested in the Council by Section
19 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham
20 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
21 and approved by the Acting Deputy Assistant Secretary - Indian
22 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
23 the Act of June 18, 1934 (48 Stat. 984).



submittal.


