3	resolutions: to govern the conduct of members of the Tohono O'odham Nation and
4	other persons within its jurisdiction and to exercise the following fiscal powers: to levy
5	duties, fees, taxes and assessments on any person, corporation or association residing
6	or doing business within the Tohono O'odham Nation" (Constitution of the Tohono
7	O'odham Nation, Article VI, Section 1(c)(1); (d)(4)); and
8	WHEREAS, CADDO Design, Inc. has failed to comply with the Nation's Transaction Privilege Taxes
9	Ordinance, and other laws, by refusing to pay taxes duly owed to the Nation; and
10	WHEREAS, this resolution has been reviewed by the Domestic Affairs Committee which
11	recommends approval by the Legislative Council.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
13	authorizes and directs the Office of Attorney General to initiate and represent the
14	Nation in litigation of claims against CADDO Design, Inc.
15	BE IT FINALLY RESOLVED that the Office of the Treasurer and the Office of the Attorney General
16	are directed to research and evaluate additional claims against CADDO Design, Inc.
17	and to make recommendations to the Legislative Council for further action as
18	appropriate.
